The City Council of the City of Northfield hereby approves the final payment for the City Hall Window Maintenance Project.

SUMMARY

The City Council is being asked to approve the final payment for the City Hall Window Maintenance Project, which is \$64,444.00. The lump sum construction contract of \$250,100.00 was awarded to Healy Construction, Inc. After award there were three change orders to the contract, which resulted in a net decrease of \$13,485.00 for a final contract amount of \$236,615.00. These changes are detailed in the table below.

Staff has reviewed the final project and the minor remaining items have been completed. The project will be covered with a one-year warranty.

FINANCIAL

The project was financed through a combination of Energy Efficiency Conservation Block Grant, bond proceeds from the Johnson Controls agreement and the Facilities Fund. The original estimated funding as presented at the September 7, 2010 City Council meeting was \$301,000; however, through cost reduction efforts the final total funding required is \$287,883.35. The fund sources and amounts are broken down in the following table.
