A variety of housing options, including rental housing, should be available as first-time homebuyers have families, become empty-nesters, become elderly and eventually need assisted living services. The historic neighborhoods that contribute to Northfield's sense of place and character will be protected. Green technology, environmental considerations, and strong neighborhood qualities should be combined to provide a safe, secure and pleasing living environment.	On-Target	In 2013, Northfield in conjunction with Three Rivers Developers created a LEED Certified Silver townhome project that serves low income and disenfranchised citizens.
