The Fond du Lac Reservation Business Committee, on behalf of the Fond du Lac Band of Lake Superior Chippewa, hereby enact the following Resolution:

- WHEREAS, the Fond du Lac Band of Lake Superior Chippewa are a sovereign people, who occupy the Fond du Lac Reservation and retain their aboriginal rights of self-government and self-determination pursuant to the Treaty of LaPointe of September 30, 1854, 10 Stat. 1109; the Indian Reorganization Act of 1934, 25 U.S.C. § 461 et seq.; the common law of the United States; and as recognized by the United Nations Declaration on the Rights of Indigenous Peoples of September 13, 2007; and
- WHEREAS, it is the sovereign obligation of the Fond du Lac Reservation Business Committee, as the duly-constituted governing body of the Fond du Lac Band, to exercise the responsibilities of self-government and management over the Band's affairs; and
- WHEREAS, the Fond du Lac Reservation Business Committee is committed to sustainability initiatives promoting human health and the protection, management and conservation of the natural resources of the Reservation;
- WHEREAS, Minnesota GreenStep association is a voluntary challenge, assistance and recognition program to help cities and Tribal Nations achieve their sustainability goals;
- NOW THEREFORE BE IT RESOLVED, that the Fond du Lac Reservation Business Committee authorizes the Fond du Lac Band of Lake Superior Chippewa to participate in the Minnesota GreenStep program. Passage of this participation resolution allows the Fond du Lac Band to be recognized as a Step One GreenStep Tribal Nation; and
- BE IT FURTHER RESOLVED, that the Fond du Lac Reservation Business Committee hereby appoints Shannon Judd and Andrea Junker to serve as the Fond du Lac Band's GreenStep coordinators.
